**Executive Summary**

**8/10/20 GOVERNOR:** There was no press conference today, however Governor DeWine's spokesperson did address the recent unemployment compensation order that President Trump signed. The order provides states with the ability to give unemployment claimants and additional \$300 that is federally funded, and the states have the option to provide an additional \$100 through state funds.

According to the spokesperson, Ohio will be going forward with the \$300/claimant option since it is quicker to implement. Option two would require General Assembly approval.

MHAS – promulgate rules for the licensing of residential facilities and opioid addiction treatment programs, and the operation of the program for the pre-admission screening and resident review for nursing facility applicants and residents with serious mental illness

ODJFS - promulgate rules relating to the administration of child daycare, publicly funded child care, child day camps, and in-home aides in Ohio to ensure the health and safety of our children and professionals, including wearing face masks

DSA - promulgate rules to conduct yearly performance assessments to determine whether community action agencies are in compliance with section 122.69 of the Ohio Revised Code
