### **Executive Summary**

**GOVERNOR:** Ohio Governor Mike DeWine and Lt. Governor Jon Husted today unveiled their Executive Budget for Fiscal Years 2022 to 2023, which includes an aggressive plan to spur Ohio's continued recovery by investing in communities, people, and businesses. Through the Investing In Ohio Initiative, the Executive Budget launches a strategic effort to invest more than \$1 billion toward accelerating economic growth and ensuring economic vitality. **Please see full press release attached to the email.** 

1/28/2021 Governor DeWine announced that COVID-related hospitalizations are at 2,829. Tonight, Ohio starts the 11:00 PM curfew because we have had 7 days in a row below 3,500 hospitalizations. The numbers will be looked at again in 2 weeks to potentially move to a midnight curfew or eliminate the curfew completely.



Governor DeWine announced that Ohio Department of Health Director Stephanie McCloud signed a health order pushing back the curfew one hour, beginning January 28, 2021 at 12:01 PM and lasts through February 11, 2021 at 12:01 PM.

**VACCINES:** Starting Monday, February 1<sup>st</sup>, vaccinations will be open to Ohioans 70 and older. This week, those with intellectual or developmental disabilities and certain medical conditions have begun to receive their vaccinations. These individuals are being contacted directly about where to get vaccinated.

To help schools return safely to in-person education, vaccinating K-12 school employees is a priority. This includes teachers, bus drivers, cafeteria workers, custodians – anyone who is in a school building. One goal for the vaccine distribution is to get kids back in school by March 1. Every public school in the state, except for one, has agreed to go back to class by March 1. Schools with access to vaccines next week have been notified. Tomorrow, all schools will be notified for which week they will receive their vaccinations.

**PUBLIC HEALTH ADVISORY SYSTEM:** The Public Health Advisory System map has been updated. Hamilton County is no longer purple, and the rest of the state remains the same.

**TRAVEL ADVISORY:** The Travel Advisory has been updated. Comparing the list from last week to this week, not much has changed, however, Georgia and Tennessee have been removed from the list.

**TESTING LOCATIONS:** DeWine has started a walk-up/drive-up testing initiative with the Ohio Association of Community Health Centers and their affiliate members and the Ohio National Guard. These sites will also include other local community-based organizations i.e., faith-based organizations, community centers, food pantries, etc.

Testing for this initiative will be available for individuals with or without symptoms. The test has no outof-pocket cost to the patient and individuals of any age are able to access the test. Minors will need signed consent of a parent/guardian.

What do you do if you have symptoms of COVID? Contact your doctor. If you don't have a doctor, but have insurance, check to see if your insurance has tele-health and see a doctor. If your doctor does not recommend a COVID test but you need one, call the Tiffin Community Health Center, 419.455.8140 and make an appointment.

PCR swab tests may take 4-6 days to return results as they must be sent to a lab and be cultured to test for the virus. Rapid tests have a must shorter return time, but are in short supply. No test is 100% accurate. The test relies on, among other things, the amount of virus in your sytem at the time of the test. Tests are available at the following locations:

The Public Health Advisory System shows that Seneca County has met 5 of the 7 indicators needed to change the level. # Key Points:

- Regionally, there are 354 COVID-19 patients with 217 (61%) in Lucas County hospitals, 55 (16%) in Allen County hospitals, and the remaining 83 (23%) from other NW Ohio counties
- Regionally, there are 94 COVID-19 Critical Care patients with 62 (66%) in Lucas County hospitals, 13 (14%) in Erie County hospitals, 11 (12%) in Allen County hospitals, and the remaining 8 (8%) from other NW Ohio counties



- Regionally, there are 58 COVID-19 patients on ventilators
- According to ODH dashboard, Region 1 has begun 86,970 vaccines as of 01/29/2021
- Out of 38 regional hospitals reporting, 14 hospitals reported strained or critical nursing shortages (37%)
- The statewide median age for COVID-19 is 42 years old
- The statewide 7-day average positivity rate for testing is 8.2%

**UNEMPLOYMENT:** Obioans filed 49,974 initial applications for unemployment compensation last week, according to the Department of Job and Family Services. The total represented an increase of 6,999, or about 16%, compared with the previous week.

ODJFS reported residents filed 262,999 continued jobless claims last week, down from 265,467 the week prior. The agency said it has sent more than \$8 billion in unemployment compensation payments to more than 908,000 workers over the last 45 weeks.

The U.S. Department of Labor reported 847,000 new claims were filed nationwide last week, down 67,000 from the previous week's revised level.
