## **Executive Summary**

**GOVERNOR:** DeWine announced today that Ohio State University is going to start producing the testing materials that are needed in order to collect a sample from patients. They are also working to increase the testing machine capacity so that more tests can be run each day.

Gov. Mike DeWine announced Friday that his administration is asking local judges to consider the early release of 38 of the state's nearly 49,000 prison inmates due to the COVID-19 pandemic, noting 23 are new mothers or are pregnant, while the other 15 are over the age of 60 and are within 60 days of their scheduled release. He said those 38 convicts are non-violent and aren't sex offenders. He said his administration will continue to examine whether more inmates can safely be released.

The administration also announced the closure of Hocking Hills State Park as a result of increased use of the narrow paths and trails.

**HOSPITAL CAPACITY:** General Harris said they are able to strategize regionally to ensure that the hospitals can reserve their space for the acute cases. They will be working to retrofit other facilities for

less severe cases. Harris said that their team will be focusing on existing infrastructure rather than building new facilities.

While everyone is being asked to avoid mass gatherings, it's very important to note that blood drives are *not* considered "mass gatherings."

## City of Tiffin

Mayor's Message: All City of Tiffin Municipal buildings shall remain closed to the public, except for employees of the city through the end of day May 1, 2020. ## Job and Family Services

For the week ending March 28, 2020, the Ohio Department of Job and Family Services reported 272,117 initial jobless claims to the U.S. Dept. of Labor, which set a record for the second straight week. The number of initial jobless claims filed in Ohio over the last two weeks stands at 468,414. To put that in perspective, 364,603 initial jobless claims were filed during the entire YEAR in 2019. Over these last two weeks, we have issued unemployment compensation payments totaling more than \$45 million to more than 108,000 claimants.

The Ohio Department of Job and Family Services urges individuals to file their claims online, if possible, at unemployment.ohio.gov.

## EMS

# Law Enforcement

The Seneca County Sheriff has ended prisoner visitation for the foreseeable future to limit exposure to the inmates and staff of the jail and Sheriff's department personnel.

Tiffin City Police officers are taking reports by phone as much as is prudent, but still responding to emergency calls. Officers will remain on patrol throughout the city.

Fostoria Police Officers are also taking reports and patrolling; responding to emergencies as needed.

## Administration

Andrew Saul, Commissioner of Social Security, reminds the public that Social Security and Supplemental Security Income (SSI) benefit payments will continue to be paid on time during the COVID-19 pandemic. The agency also reminds everyone to be aware of scammers who try to take advantage of the pandemic to trick people into providing personal information or payment via retail gift cards, wire transfers, internet currency, or by mailing cash, to maintain Social Security benefit payments or receive economic impact payments from the Department of the Treasury.

"Social Security will pay monthly benefits on time and these payments will not be affected by the COVID-19 pandemic," Commissioner Saul said. "I want our beneficiaries to be aware that scammers may try to trick you into thinking the pandemic is stopping or somehow changing your Social Security payments, but that is not true. Don't be fooled."
