## **Executive Summary**

GOVERNOR: The Governor did not hold his daily press conference today.

DINE SAFE OHIO ORDER: Director Acton Friday signed an amended "Dine Safe Ohio Order," which updates to various requirements and recommendations, including dance floors which are permitted but must follow social distancing protocols.

ODH has also amended its order regarding access to Ohio's nursing homes, allowing visitation to occur in a socially distant manner provided it is done outdoors so the visitor does not enter the facility.
