Executive Summary

GOVERNOR: The Governor did not hold a COVID-19 press conference today.

CENTERS FOR DISEASE CONTROL: As restaurants begin to reopen, the CDC has issued guidance related to the transmission of COVID-19 through food. Currently there is no evidence to suggest that handling food is associated with COVID-19. The guidance includes the following facts:

The risk of getting COVID-19 from food you cook yourself or from handling and consuming food from restaurants and takeout or drive-thru meals is thought to be very low. Currently, there is no evidence that food is associated with spreading the virus that causes COVID-19.

The risk of infection by the virus from food products, food packaging, or bags is thought to be very low. Currently, no cases of COVID-19 have been identified where infection was thought to have occurred by touching food, food packaging, or shopping bags.



Although some people who work in food production and processing facilities have gotten COVID-19, there is no evidence of the virus spreading to consumers through the food or packaging that workers in these facilities may have handled.

Ohio State Fair:

The Expo Commission has cancelled the 2020 Ohio State Fair due to the COVID-19 pandemic. The Ohio State Fair's management team along with the Ohio Expo Commission evaluated information from state and local health officials, along with the financial feasibility of a reduced attendance over the past several weeks.

The Health Department reports 31 total confirmed cases of the COVID-19 virus including 28 people who have recovered from the illness and two who have died due to complications of COVID19.

Emergency Management Agency

Do not click on links or respond to texts saying you have been exposed to COVID-19.
