## **Executive Summary**

**GOVERNOR:** Citing objections from health care professionals and business leaders as being detrimental to pandemic response and public health, Ohio Governor Mike DeWine today vetoed Substitute Senate Bill 311, stating in his veto message that "it is not in the best interest of protecting the health and safety of all Ohioans."



Senate Bill 311 prohibits the ODH Director from issuing general, mandatory orders of isolation, and gives the General Assembly the ability to rescind ODH orders preventing the spread of infectious diseases.

VACCINES: During today's press conference, Governor DeWine gave more details about the vaccines that are expected to arrive in the coming weeks. He has planned a press conference tomorrow to focus on the plan for vaccine distribution and administration.

PUBLIC HEALTH ADVISORY SYSTEM: We have updated the map below. Franklin County has been removed from the purple tier, however Medina, Summit, Portage, Richland and Stark counties have all been added.

TRAVEL ADVISORY MAP: The map of states in which Ohioans are asked to quarantine when returning from has been updated. Ohio has now reached the 15% positivity rate, the threshold for travel advisories for other states. The latest map is attached to the email.

UNEMPLOYMENT: Ohioans filed 27,750 initial applications for unemployment compensation last week, according to data released Thursday by the Ohio Department of Job and Family Services. The total represented an 8% decline from the previous week, when residents filed 30,177 jobless claims.

The agency reported Ohioans filed 256,776 continued claims last week, down from 263,737 the week before.

## PHASED APPROACH TO ADMINISTRATION

The administration has yet to finalize a phased approach to the administration of the vaccine, however he is expected to unveil details of that plan Friday, December 4th, with health care workers and first responder anticipated to be among the first to receive doses.



**TESTING LOCATIONS:** DeWine has started a walk-up/drive-up testing initiative with the Ohio Association of Community Health Centers and their affiliate members and the Ohio National Guard. These sites will also include other local community-based organizations i.e., faith-based organizations, community centers, food pantries, etc.

Testing for this initiative will be available for individuals with or without symptoms. The test has no outof-pocket cost to the patient and individuals of any age are able to access the test. Minors will need signed consent of a parent/guardian.

**Travel Advisory:** Those entering Ohio after traveling to states reporting positive testing rates of 15% or higher for COVID-19 are advised to self-quarantine for 14 days.

The list of states will be updated every week on Wednesday. Based on a 7-day rolling average of positivity rates of November 18, the affected states are highlighted in yellow on the attached map.

The Seneca County Board of Commissioners heard positive reports from Tiffin-Seneca Economic Partnership and Great Lakes Community Action Partnership Thursday morning concerning grants awarded to assist residents, businesses and nonprofits to help deal with the adverse impact of the COVID-19 pandemic.

The commissioners previously committed about \$1.25 million to five area agencies to help those negatively affected by the health crisis. The funds were allocated to Tiffin-Seneca Economic Partnership, Fostoria Economic Development Corp., Great Lakes Community Action Partnership, Tiffin-Seneca United Way and Seneca County Department of Job and Family Services.

On Thursday, TSEP Rural Development Manager Audrey Flood reported that 126 businesses were assisted through the county's allocation.

Flood said local jurisdictions were invited to participate in the program, with seven entities pitching in. A total of \$846,146 was made available including about \$400,000 from Seneca County. The city of Tiffin contributed \$241,650, while Green Springs, Bettsville and Clinton, Bloom, Hopewell, Eden and Pleasant townships also contributed CARES Act money to assist local businesses through TSEP.

The commissioners initially committed \$300,000 to the program but added on nearly \$100,000 more Thursday to make sure all eligible applicants were funded. Flood said 126 businesses received funding and a total of \$846,146 was awarded. Disbursement is underway this week. Flood said \$486,000 of the funds went to rural businesses outside of the two cities, this marks about 58 percent of the total amount.

The businesses that received help each had at least a 15-percent decline in revenue due to the pandemic. The commissioners thanked TSEP personnel for their hard work in getting the money rolled out to the organizations and businesses that needed it the most. Although the application deadline for the TSEP and FEDC programs has passed, residents may still reach out to GLCAP, Tiffin-Seneca United Way or Seneca County DJFS for information on how to apply for funding. Several programs are available, including mortgage, rent, food and utility assistance. GLCAP President RuthAnn House also gave a brief, but positive report.

"We are doing extremely well in serving people with the Cares Act dollars," she said. "We are estimating that by the end of this week, we will have expended all the funds (provided by the commissioners)."

The commissioners allocated \$250,000 in an attempt to assist those in the community who are in need due to COVID-19.

House said she would provide a more formal report in January when figures are finalized.

In other business, the commissioners briefly previewed an upcoming meeting to be held at 7 p.m. Monday via Zoom. The meeting will be dedicated to emergency medical services discussion, and the board is expected to be joined by Joint Ambulance District leadership. Also during the meeting, the commissioners affirmed its December meeting schedule. The board plans to meet for board sessions on Dec. 10 and 17, with additional meetings scheduled for the 22nd and 29th, if needed.

During new business, the board accepted:

\* Appointing Patricia Smith to the Seneca County (169) Board for Seneca County Opportunity Center.

\* Authorizing Seneca County Job and Family Services to transfer TANF funds to Morrow County Job and Family Services.

\* Establishing the Fiscal Year 2020 COSSAP Fund on behalf of the Seneca County Sheriff's Office.

\* A \$5,000 supplemental appropriation for CARES Act money, amended to remedy a calculation error.

What do you do if you have symptoms of COVID? Contact your doctor. If you don't have a doctor, but have insurance, check to see if your insurance has tele-health and see a doctor. If your doctor does not recommend a COVID test but you need one, call the Tiffin Community Health Center, 419.455.8140 and make an appointment.

PCR swab tests may take 4-6 days to return results as they must be sent to a lab and be cultured to test for the virus. Rapid tests have a must shorter return time, but are in short supply. No test is 100% accurate. The test relies on, among other things, the amount of virus in your sytem at the time of the test. Tests are available at the following locations:

# Key points:

- Regionally, there are 758 COVID-19 patients with 428 (57%) in Lucas County hospitals, 100 (13%) in Allen County hospitals, and the remaining 230 (30%) from other NW Ohio counties
- Regionally, there are 193 COVID-19 Critical Care patients with 131 (68%) in Lucas County hospitals, 17 (9%) in Allen County hospitals, and the remaining 45 (23%) from other NW Ohio counties
- Out of 38 regional hospitals reporting, 20 hospitals reported strained or critical nursing shortages (53%)
- The number of COVID-19 hospitalized patients in Region 1 and Regions 1, 2 and 5 (Zone 1) combined continues to increase
  - o Region 1 COVID-19 hospitalized patients are higher than our previous peak in the 200-330 range in mid-April
  - o Zone 1 COVID-19 hospitalized patients are higher than our previous peak in the 690-700 range in mid-April
- Cases reported through the Ohio Department of Health continue to increase substantially each day



- The statewide median age for COVID-19 is 42 years old
- The statewide 7-day average positivity rate for testing is 15.1%
